



Board of Directors Nomination Form

The Silver Star Resort Association (SSRA) doing business as Destination Silver Star (DSS) is calling for nominations to the Board of Directors. Candidates must be nominated by two (2) Association “voting” members in good standing for one of seven (7) open positions. A member is not limited to nominating an individual only within the category to which the member belongs. The nominators must either be an Owner of a Resort Lot, a Non-Resident Business Owner, or an Occupier. **Candidates may stand as a candidate in any one of the categories open for election and must choose their preferred category in which to run.**

If you wish to apply for nomination as a directorship candidate, you must complete the Nomination Form on the next page, sign it, and obtain the signatures of two nominators as well as sign the [Board of Terms & FAQ document](#).

The election will be conducted electronically during the period May 1st through 7th, 2025. The results of the election will be announced on May 9th, 2025.

Seven (7) Directors will be elected for the Silver Star Resort Association (“SSRA”) dba Destination Silver Star (“DSS”) Board of Directors. They are as follows:

- **Residential Lodging Director (2-year term) by advance vote (1)**
- **Residential Director (2-year term) by advance vote (1)**
- **Hotel Lodging Director (2-year term) by advance vote (2)**
- **At Large Director (2-year term) by advance vote (2)**
- **Commercial Director (2-year term) by advance vote (1)**

A brief (maximum 150 words) biography, written in the 3rd person (not “I”), must accompany your Nomination Form as well as a headshot photo (minimum resolution 300dpi, no smaller than 1280 x 960 pixels). The biography will give the Silver Star community your qualifications and strengths as a board candidate, allowing an informed candidate selection prior to voting.

Nomination forms and accompanying materials will be accepted until 11:59pm on April 21st, 2025.
